3 Object of the declaration

Packaging group	Sample packaging
Function	Sales packaging for Exymes sample and evaluation material placed on the European Union market

The packaging comprises the following components:

- Grip seal bag, LDPE, 40-micron, containing greater than 30 per cent recycled content
- Reagent tubes, polypropylene
- Applied labels, clear polypropylene stock, printed in-house

Transport packaging: corrugated board outer box, in one of three formats selected by consignment size.

4 Declaration

This Declaration of Conformity is issued under the sole responsibility of the manufacturer.

The object of the declaration described above is in conformity with the applicable requirements of Regulation (EU) 2025/40 of the European Parliament and of the Council on packaging and packaging waste.

Conformity with Article 5 on substances in packaging is evidenced by supplier declarations held on file for every component, covering the combined content of lead, cadmium, mercury and hexavalent chromium against the limit of 100 mg/kg, per- and polyfluoroalkyl substances, and substances of very high concern under Regulation (EC) No 1907/2006 (REACH). The requirements of Articles 6, 7, 10 and 12 apply from the dates set in the Regulation and are addressed in the technical documentation as those dates approach.

Notified body	Not applicable. No notified body is required for internal production control.

6 References

No harmonised standards or common specifications have been adopted under Articles 36 and 37 of Regulation (EU) 2025/40 in relation to the requirements declared. Conformity is declared by reference to the following technical specifications:

- Third-party analytical testing reported by suppliers where available.
